THERE ARE NOW TWO TRANSITIONAL HOUSING FACILITIES, NINE FULL TIME MANAGEMENT STAFF, AND 28 ARTISANS (WOMEN FREED, EMPOWERED, AND EMPLOYED). THERE IS ALSO A TRAINING CENTER IN THE HEART OF THE BROTHEL SYSTEM TO ACCELERATE THE FREEDOM PROCESS FOR THE ENSLAVED. THE TRAINING CENTER HAS 6 FULL TIME AND 4 PART TIME STAFF SERVING THE WOMEN IN THE AREA THROUGH DAILY ENGAGEMENT AT THE BROTHELS, TRAUMA FOCUSED COGNITIVE BEHAVIORAL THERAPY, AND SKILL & TRADE DEVELOPMENT.
